Subject: Assignment of GSA from GAIL to GAIL Gas Ltd. regarding natural gas supply in Agra-Firozabad

Dear Sir,

It is a matter of great pleasure to inform you that GAIL (India) Ltd. (hereafter referred to as "GAIL") has formed a wholly owned subsidiary company viz. GAIL Gas Ltd. in order to put in a focussed approach in serving the various retail customers for CGD projects in various cities across the country. Accordingly, GAIL has transferred the entire local network for Gas distribution in Agra-Firozabad to GAIL Gas Ltd.

In pursuance of the Gas Supply Agreement (GSA) signed between Buyer and Seller (GAIL (India) Ltd.) for the supply of APM gas and/or RLNG to your plant at Agra-Firozabad as per the terms and conditions provided thereof, and in pursuance of the notice given by GAIL under Article 12 of the GSA, it is hereby informed that with effect from 16th November 2011, the APM GSA and the RLNG Supply Contract between the parties stands assigned by GAIL (India) Ltd. to GAIL Gas Limited as the 'Seller' (hereinafter referred to as 'GAIL Gas').

Accordingly, effective 16th November 2011, all rights, duties and obligations of the Seller under the GSA shall be exclusively to the entitlement of GAIL Gas and all duties/obligations under the GSA to be performed by Seller shall be performed by GAIL Gas as the Seller.

Effective 16 November 2011, for all purposes under the GSA, reference to 'Seller' shall mean a reference to GAIL Gas Ltd. and reference to party shall mean a reference to GAIL Gas wherever context so requires and admits.

Accordingly you are requested to take necessary action for submission of an amended or a fresh LC/Bank Guarantee as per the GSA in favour of GAIL Gas latest by 28th November 2011. The amendment should be as under: "The name of beneficiary may be read as "GAIL Gas Ltd" in place of "GAIL (India) Ltd." The amended / fresh LC / BG may be submitted to the Gail Gas office at AGRA
